AN ORDINANCE AUTHORIZING THE CITY OF DERIDDER, LOUISIANA TO ENTER INTO AN INTERAGENCY AGREEMENT WITH THE LOUISIANA DEPARTMENT OF PUBLIC SAFETY AND CORRECTIONS FOR THE PURPOSE OF PROVIDING OFFENDER LABORERS FOR USE BY THE CITY UPON ITS PUBLIC ROADS, STREETS, LEVEES, PUBLIC BUILDINGS, PUBLIC WORKS AND PUBLIC IMPROVEMENTS; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.
