    1. AN ORDINANCE AUTHORIZING THE CITY OF DERIDDER TO ENTER INTO A CONTRACT WITH LANDMARK AMERICAN INSURANCE COMPANY THROUGH MCGRUFF INSURANCE SERVICES, INC. FOR THE PURPOSE OF PROVIDING A PACKAGE OF COMMERCIAL PROPERTY INSURANCE FOR THE 1ST STREET SCHOOL, AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.
    2. AN ORDINANCE ENLARGING THE CORPORATE LIMITS OF THE CITY OF DERIDDER, LOUISIANA, UNDER AUTHORITY OF
