 1. AN ORDINANCE AUTHORIZING A SPECIAL EXCEPTION USE GRANTING TREKEISHA ANDERSON AUTHORITY TO USE HER PROPERTY LOCATED AT 402 EAST 5TH STREET, PRESENTLY ZONED R-3 (MULTIPLE-FAMILY RESIDENTIAL DISTRICT) FOR THE PURPOSE OF PLACING A CLASS B MOBILE HOME TO BE USED AS HER RESIDENCE, NOT TO EXCEED TEN (10) YEARS AND ONLY AS LONG AS SHE OWNS SAID PROPERTY AND RESIDES THEREON, AND
