 1. AN ORDINANCE AUTHORIZING CITY OF DERIDDER, LOUISIANA ("CITY"), THROUGH ITS MAYOR, TO ENTER INTO

A CONTRACT WITH THE LINCOLN NATIONAL LIFE INSURANCE COMPANY EFFECTIVE JULY 1, 2018 FOR THE PROVISION OF DISABILITY AND LIFE INSURANCE FOR THE EMPLOYEES OF THE CITY OF DERIDDER, AUTHORIZING PAYMENT OF THE PREMIUM IN CONNECTION THEREWITH, AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.
