 1. AN EMERGENCY ORDINANCE AUTHORIZING THE CITY OF DERIDDER THROUGH ITS MAYOR TO ENTER INTO A COOPERATIVE AGREEMENT WITH THE BEAUREGARD PARISH TAX ASSESSOR, BEAUREGARD PARISH SHERIFF, BEAUREGARD PARISH POLICE JURY, BEAUREGARD PARISH SCHOOL BOARD, AND THE TOWN OF MERRYVILLE FOR THE
