 1. AN ORDINANCE ADOPTING THE OPERATING BUDGET OF REVENUES, OTHER FINANCING SOURCES AND EXPENDITURES FOR THE CITY OF DERIDDER, LOUISIANA FOR FISCAL YEAR 2018-2019, BEGINNING OCTOBER 1, 2018.
 2. AN ORDINANCE GRANTING A VARIANCE FOR ISSUANCE OF A CITY OF DERIDDER LICENSE FOR SALE OF ALCOHOLIC BEVERAGES TO ROSE EPPERSON DOING BUSINESS AS EAT-A-BITE CATERING SERVICE, BUT ONLY FOR CATERED EVENTS HELD AT LOCATIONS OTHER THAN HER BUSINESS LOCATION AT 401 MARTIN LUTHER KING DRIVE, DERIDDER,

LOUISIANA 70634 AND SO LONG AS SAME ARE OTHERWISE IN COMPLIANCE WITH ALL OTHER ORDINANCES OF THE CITY OF DERIDDER, LOUISIANA, INCLUDING, BUT NOT LIMITED TO, CHAPTER 2.4, "ALCOHOLIC BEVERAGES", OF THE CITY'S CODE OF ORDINANCES.

3. AN ORDINANCE AUTHORIZING A CONDITIONAL REZONING OF PROPERTY LOCATED AT MUNICIPAL ADDRESS, 1013 MCARTHUR STREET, DERIDDER, LOUISIANA, AND BEING MORE FULLY DESCRIBED IN THE BODY OF THIS ORDINANCE, SAID PROPERTY BEING PRESENTLY ZONED R-1 (SINGLE FAMILY RESIDENTIAL DISTRICT) TO BE REZONED R-3 (MULTIPLE-FAMILY RESIDENTIAL DISTRICT), AS REQUESTED BY GLADYS BRAZZLE, AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.
