 1. **AN ORDINANCE ADOPTING THE OPERATING BUDGET OF REVENUES AND EXPENDITURES FOR THE CITY OF DERIDDER, LOUISIANA FOR FISCAL YEAR 2017-2018, BEGINNING OCTOBER 1, 2017.**
