 1. AN ORDINANCE AUTHORIZING THE FILING OF AN APPLICATION WITH THE LOUISIANA DIVISION OF ADMINISTRATION, OFFICE OF COMMUNITY DEVELOPMENT, FOR A GRANT TO PARTICIPATE IN THE LOCAL GOVERNMENT ASSISTANCE PROGRAM (LGAP)/COMMUNITY WATER ENRICHMENT FUND (CWEF) PROGRAM FOR THE PURPOSE OF REHABILITATION, IMPROVEMENT, AND CONSTRUCTION PROJECTS FOR COMMUNITY WATER SYSTEMS TO PROVIDE SAFE AND CLEAN DRINKING WATER WITHIN THE CITY LIMITS.
