A. Introductions.

AN ORDINANCE AUTHORIZING THE CITY OF DERIDDER THROUGH ITS MAYOR TO ENTER INTO A COOPERATIVE ENDEAVOR WITH THE STATE OF LOUISIANA, DIVISION OF ADMINISTRATION, FOR THE PURPOSE OF FUNDING THE WATER, SEWER, AND/OR STORM WATER INFRASTRUCTURE PROJECT IN ACCORDANCE WITH THE CITY'S APPLICATION TO THE WATER SECTOR PROGRAM, AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.
2. AN ORDINANCE AUTHORIZING THE CITY OF DERIDDER, LOUISIANA, THROUGH ITS MAYOR, TO ENTER INTO AN AGREEMENT WITH CIVICPLUS, LLC EFFECTIVE JUNE 1, 2023 FOR PROFESSIONAL SERVICES FOR THE CODIFICATION OF CITY'S MUNICIPAL CODE, AUTHORIZING PAYMENT IN CONNECTION THEREWITH, AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

3. AN ORDINANCE AUTHORIZING THE CITY OF DERIDDER THROUGH ITS MAYOR TO ENTER INTO A COOPERATIVE ENDEAVOR AGREEMENT WITH DERIDDER BASEBALL AND SOFTBALL, INC. FOR A PART OF WEST PARK FOR RECREATION OF THE YOUTH OF THE AREA FROM MARCH 13, 2023 THROUGH JULY 31, 2023, AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.
