    1. AN ORDINANCE TO ESTABLISH THE CITY COUNCIL MEETING SCHEDULE AND THE HOLIDAY SCHEDULE ON WHICH CITY OFFICES ARE TO BE CLOSED FROM JANUARY 2022 TO DECEMBER 2022.
