A. **Introductions.**
 1. AN ORDINANCE ADOPTING THE AMENDED OPERATING BUDGET OF REVENUES, OTHER FINANCING SOURCES AND EXPENDITURES FOR THE CITY OF DERIDDER, LOUISIANA FOR FISCAL YEAR 2022-2023, BEGINNING OCTOBER 1, 2022.
 2. AN ORDINANCE AUTHORIZING CITY OF DERIDDER, LOUISIANA ("CITY"), THROUGH ITS MAYOR, TO ENTER INTO A CONTRACT WITH HUMANA GROUP MEDICARE ADVANTAGE EFFECTIVE JANUARY 1, 2024 FOR THE PROVISION OF HEALTH INSURANCE FOR ACTIVE OR RETIRED CITY OF DERIDDER EMPLOYEES OVER THE AGE OF SIXTY-FIVE, AUTHORIZING PAYMENT OF THE PREMIUM IN CONNECTION THEREWITH, AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

8. AN ORDINANCE AUTHORIZING THE CITY OF DERIDDER, THROUGH ITS MAYOR, TO ENTER INTO A CONTRACT WITH MAGUIRE IRON, INC. FOR THE WATER SECTOR PROGRAM—MAYS STREET ELEVATED TANK REHABILITATION, M.A. PROJECT NO. A8-22086-DA, AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

AN ORDINANCE AUTHORIZING A SPECIAL EXCEPTION USE GRANTING SONYA BELLAMY AUTHORITY TO USE HER PROPERTY LOCATED AT 709 RAND SIMMONS STREET, PRESENTLY ZONED R-3 (MULTIPLE-FAMILY RESIDENTIAL DISTRICT) FOR THE PURPOSE OF PLACING A CLASS B MOBILE HOME TO BE USED AS HER RESIDENCE, AND ONLY AS LONG AS SHE OWNS SAID PROPERTY AND RESIDES THEREON, AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

3. AN ORDINANCE AUTHORIZING THE CITY OF DERIDDER, LOUISIANA, THROUGH ITS MAYOR, TO ENTER INTO A LEASE AGREEMENT WITH DANCE STOP CENTRE, L.L.C.; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.
4. AN ORDINANCE AUTHORIZING THE CITY OF DERIDDER THROUGH ITS MAYOR TO ENTER INTO A CONTRACT WITH SERVER AT WORK, LLC FOR PROVIDING INFORMATION TECHNOLOGY MANAGED SERVICES FOR ALL PUBLIC BUILDINGS OWNED BY THE CITY, AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.
