A. Introductions.

1. AN ORDINANCE AUTHORIZING THE CITY OF DERIDDER, THROUGH ITS MAYOR, TO ENTER INTO A CONTRACT WITH THE DIVISION OF ADMINISTRATION OF THE OFFICE OF COMMUNITY DEVELOPMENT, STATE OF LOUISIANA, FOR THE PURPOSE OF INSTALLING A SUBSURFACE PLASTIC PIPE DRAIN SYSTEM IN THE RAINBOW FOREST SUBDIVISION WITHIN THE CITY LIMITS; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.
2. 3. AN ORDINANCE AUTHORIZING THE CITY OF DERIDDER, THROUGH ITS MAYOR, TO ENTER INTO A CONTRACT WITH APECK CONSTRUCTION, LLC FOR THE KILMAN PINES DRAINAGE IMPROVEMENTS PROJECT, AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

AN ORDINANCE AUTHORIZING THE CITY OF DERIDDER, THROUGH ITS MAYOR, TO ENTER INTO A COOPERATIVE ENDEAVOR AGREEMENT WITH THE STATE OF LOUISIANA, THROUGH THE DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT, FOR THE ACCEPTANCE OF A DONATION OF RECLAIMED ASPHALT PAVEMENT, STATE PROJECT NO. H.014083, AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.
