 - A. **Introductions.**
 1. AN ORDINANCE AUTHORIZING THE CITY OF DERIDDER, THROUGH ITS MAYOR, TO ENTER INTO A CONTRACT WITH THE DIVISION OF ADMINISTRATION OF THE OFFICE OF COMMUNITY DEVELOPMENT, STATE OF LOUISIANA, FOR THE PURPOSE OF REPLACING THE BOWER STREET WATER LINE; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

2. AN ORDINANCE ABANDONING A PORTION OF PORTER STREET WITHIN THE CORPORATE LIMITS OF THE CITY OF DERIDDER FROM THE EAST BORDER OF THE PROPERTY LINE OF GRACE CHURCH OF DERIDDER, LA., INC. LOCATED AT 1104 PORTER STREET AT THE INTERSECTION OF BLANKENSHIP DRIVE AND PORTER STREET TO THE WEST BORDER OF THE PROPERTY LINE OF HESTER’S PAINT & BODY SHOP, LLC IDENTIFIED BY PARCEL NO. 033662133, RESERVING, HOWEVER, UNTO THE CITY, AND UNTO ANY AND ALL THIRD PARTIES TO WHOM CITY HAS GRANTED SUCH, PREDIAL SERVITUDES OF PASSAGE AND UTILITIES IN, ON AND UNDER SAID IMMOVABLE PROPERTY, TOGETHER WITH ALL RIGHTS OF REPAIR AND REPLACEMENT ASSOCIATED THEREWITH; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

3. AN ORDINANCE AUTHORIZING THE CITY OF DERIDDER (HEREIN REFERRED TO AS “THIS GOVERNMENTAL UNIT”) TO JOIN WITH THE STATE OF LOUISIANA AND OTHER LOCAL GOVERNMENTAL UNITS AS A PARTICIPANT IN THE LOUISIANA STATE-LOCAL GOVERNMENT OPIOID LITIGATION MEMORANDUM OF UNDERSTANDING (THE “MOU”) AND ANY SUBSEQUENT FORMAL AGREEMENTS NECESSARY TO IMPLEMENT THE MOU, INCLUDING BUT NOT LIMITED TO, THE SUBDIVISION SETTLEMENT PARTICIPATION FORM(S) IN EXHIBIT K OF THE DISTRIBUTOR SETTLEMENT AGREEMENT AND THE JANSSEN SETTLEMENT AGREEMENT.
