 1. AN ORDINANCE AUTHORIZING A SPECIAL EXCEPTION USE GRANTING TINER B. TURNER AUTHORITY TO USE HER PROPERTY LOCATED AT 1022 OLLIE STREET, PRESENTLY ZONED R-3 (MULTIPLE-FAMILY RESIDENTIAL DISTRICT) FOR THE PURPOSE OF PLACING A 2022 CLASS B MOBILE HOME TO BE USED AS HER RESIDENCE, NOT TO EXCEED TEN (10) YEARS AND ONLY AS LONG AS SHE OWNS SAID PROPERTY AND RESIDES THEREON, AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

AN ORDINANCE AUTHORIZING THE CITY OF DERIDDER, THROUGH ITS MAYOR, TO ENTER INTO A SERVICE AGREEMENT WITH LARRY BRETT DOWDY DBA DOWDY LAWN & HARDSCAPING FOR THE PURPOSE OF FIELD MAINTENANCE SERVICES OF THE WEST PARK BASEBALL FIELDS, AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

AN ORDINANCE AUTHORIZING CITY OF DERIDDER, LOUISIANA ("CITY"), THROUGH ITS MAYOR, TO ENTER INTO A CONTRACT WITH HUMANA GROUP MEDICARE ADVANTAGE EFFECTIVE JANUARY 1, 2023 FOR THE PROVISION OF HEALTH INSURANCE FOR ACTIVE OR RETIRED CITY OF DERIDDER EMPLOYEES OVER THE AGE OF SIXTY-FIVE, AUTHORIZING PAYMENT OF THE PREMIUM IN CONNECTION THEREWITH, AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

AN ORDINANCE AUTHORIZING THE CITY OF DERIDDER, LOUISIANA, THROUGH ITS MAYOR, TO EXECUTE A VENDOR AGREEMENT WITH THE LOUISIANA HOUSING CORPORATION, FOR PARTICIPATION IN THE LOW-INCOME HOUSEHOLD WATER ASSISTANCE PROGRAM (“LIHWAP”); AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.
